

CALISTHENIC ASSOCIATION OF QUEENSLAND INCORPORATED

BYLAWS

- 1 **ORDINARY MEMBERS** must register all pupils of their club, class or college with the Calisthenic Association of Queensland Incorporated (herein known as CAQI) as Participating Members and pay the appropriate annual registration as determined from time to time by CAQI.
 1. **A monthly registration return is required to be presented to CAQI with payment of appropriate fees by the 7th day of each month.**
- 2 **LIFE MEMBERS** shall have free admission to any function organised by the Association and shall not be required to pay annual subscriptions or levies, and shall be entitled to attend at any *General Meeting* of the Association and contribute and express opinions at such meetings.
 - Life Members may not vote at Association Meetings.
 - Life Membership shall be renewed annually by the Life Member.
- 3 **NO PUPIL** may participate in CAQI events unless they are currently registered with CAQI or an Australian Calisthenic Federation (hereafter known as ACF) affiliated body.
- 4 **ONLY LEVEL 1 COACHES** registered with the CAQI or an ACF affiliated body may present teams or individual girls in CAQI sanctioned events.
- 4 **ONLY FINANCIAL MEMBERS** may organise and run events on behalf of CAQI.
- 5 **ALL ORDINARY MEMBERS** must submit to the Secretary "proposed dates" of any calisthenic event for the following year by 30th November of current year. From these a calendar will be drawn up and forwarded to members the first week in March. A reasonable interval between will exist.
- 6 **COPYRIGHT ROYALTIES:** the Association will arrange copyright cover and clubs will be levied accordingly and shall be reviewed annually.
- 7 **A PATRON** may be elected at an Annual General Meeting of the Association. Nominations for patron must be in the hands of the Secretary at least twenty-eight (28) days prior to any such Annual General Meeting. Position will not carry voting rights, but the patron will be entitled to attend functions organised by the Association.
- 8 **COMPETITION SUB-COMMITTEE** is to draw up and put into operation a five (5) year calendar for state competition locations.
- 9 **AN EXECUTIVE MEMBER** of each member club including the elected President, Secretary, Treasurer and Vice-President who is elected at the same time as the previous three. All members to be on the Executive Council.
- 10 **ABSENTEEISM.** If any member of the Committee absents himself from two (2) consecutive meetings of the Committee of Management without leave his position on the Committee shall be declared vacant by the Committee of Management.
- 11 **POSITION** of President, Secretary shall be for a period of two (2) years, the position Vice-President, Treasurer will be for one (1) year, thereafter on a rotational basis.
